Subject: Current Status of the EU REACH Regulation of Stratasys, Ltd. Printing Materials

The purpose of this letter is to provide a general description of how Stratasys, Ltd. ("Stratasys") printing materials (excluding MakerBot materials) are affected by the EU REACH Regulation, as set forth below, and the actions taken by Stratasys to fulfill obligations which may be applicable to it under the Regulation*.

The European Union Regulation (EC) No. 1907/2006, entitled "Registration, Evaluation, Authorization (and Restriction) of Chemicals" (REACH), entered into effect on June 1, 2007 (the "REACH Regulation"). The REACH Regulation established registration and notification requirements for most chemicals (substances), with some exceptions. Those chemicals subject to the REACH Regulation include, among others, chemicals with particularly severe health hazards (e.g. toxic, mutagenic, or hazardous to reproduction) referred to as "Substances of Very High Concern" (SVHC).

Pursuant to the requirements of the REACH Regulation, Stratasys is required to notify customers of the presence of any SVHC in any product sold into the EU in concentrations greater than 0.1% (wt/wt). To the best of our knowledge, based on our internal investigation and information provided by our suppliers, as at the date of this letter, Stratasys' printing materials do not contain any SVHC in concentrations at or exceeding 0.1% (wt/wt). Accordingly, notification to our customers is not required at this time.

In accordance with the general obligation under the REACH Regulation to register substances sold by Stratasys in the EU in quantities greater than one (1) metric ton, Stratasys has ensured that substances manufactured by it (excluding MakerBot substances) and requiring registration have been pre-registered and are on schedule for complete registration.

It is anticipated that all Stratasys suppliers will fully register all of the aforementioned substances requiring registration in accordance with the timeline presented in the REACH Regulation.

Stratasys is committed to comply with the requirements of REACH Regulation, as may be applicable to it. Please feel free to contact us with any questions you might have regarding the REACH status of our products.

Summary:

In accordance with the requirements to May 2015 of the REACH Regulation and to the best of our knowledge, Stratasys has taken appropriate action to complete and fulfill its registration obligations as well as SVHC notification requirements as may be applicable to it under Article 33 of the REACH Regulation with respect to substances manufactured by it (excluding MakerBot substances). Stratasys intends to continue to monitor future requirements of the REACH Regulation as well as subsequent changes to the SVHC list.
